Gunman kills 3 people, then himself at Michigan University

A gunman opened fire on Monday night at Michigan State University, killing three people and wounding five more, before fatally shooting himself off campus amid an hours-long manhunt during which frightened students hid in the dark.

Police reported the man's death early Tuesday, four hours after shootings broke out, first at Berkey Hall, an academic building, and then nearby at the MSU Union, a popular hub to eat or study.

Saudi woman set to break barrier with space mission

Saudi Arabia will send its first ever woman astronaut on a space mission later this year, according to a state media report.

"This mission is also historic, as it will make the Kingdom one of the few countries in the world that

As its name suggests, Ax-2 will be the second mission to the ISS organised by Axiom Space.

The first, Ax-1, sent three paying customers and Axiom's Michael López-Alegria, a former NASA astronaut, to the station for more than two weeks in April 2022 aboard a SpaceX Dragon capsule.

"I know there have been questions and concerns about this, but there is no - again, no indication of aliens or extraterrestrial activity - with these recent take-downs," Karine Jean-Pierre, the White House press secretary, said to reporters.

Queen Consort of Britain Camilla tests Covid positive

Britain's Queen Consort, Camilla, has tested positive for Covid after suffering from cold symptoms, Buckingham Palace has said, the second time she has caught the virus.

The 75-year-old wife of King Charles III was said to be suffering from a "seasonal" illness, but a positive Covid test has led to all her engagements for the week now being cancelled.

"After suffering the symptoms of a cold, Her Majesty the Queen Consort has tested positive for the virus," the Buckingham Palace statement said on Monday.

"With regret, she has therefore cancelled all her public engagements for this week," the statement added.
