Bangkok: Myanmar's government on Wednesday said it will draft 60,000 young men and women yearly for military service under its newly activated conscription law, with call-ups beginning after the April festival marking the country's traditional New Year. The

scription measure was activated by order of the chairman of the ruling military council, Senior Gen Min Aung Hlaing. His announcement appeared to confirm that the military has been stretched thin by increasing pressure from armed pro-democracy resistance forces.

Pentagon chief out of hospital

Washington: US Defense Secretary Lloyd Austin was released from Walter Reed National Military Medical Center on Tuesday and has resumed his full duties, the Pentagon said. Austin (70) has had ongoing health issues since undergoing surgery in December to treat prostate cancer. He was taken back to Walter Reed on Sunday for a bladder issue and admitted to intensive care for the second time since the surgery. He underwent a non-surgical procedure under general anaesthesia on Monday.

Malaysian-Indian sues airline \$1.78m

Singapore: A Malaysian-Indian former flight steward is suing Singapore Airlines (SIA) for \$1.78 million after he slipped and fell onboard a plane in 2019 resulting in spinal injuries. Duraifaj Santiran, who was employed by SIA from April 2016 to April 2021, alleged that his former employer was negligent in allowing the workplace to be unsafe. The Straits Times newspaper reported on Tuesday. The 35-year-old was in the economy-class galley of a flight from San Francisco which was scheduled to land in Singapore on the evening of Sept 6, 2019.

Rescuers search for missing miners

Ankara: Hundreds of rescuers on Wednesday pressed ahead with efforts to search for at least nine workers trapped at a gold mine in eastern Turkey that was engulfed by a massive landslide. The landslide struck the Copler mine in the town of Illic in Turkey's mountainous Erzincan province on Tuesday. Footage seemingly shot by a worker showed a huge mass of earth rushing down a gully, over-running everything in its path.

Australia: Storms ignite wildfires

Melbourne: Powerful winds have killed a man and brought widespread destruction across Australia's second-most populous state, leaving 530,000 homes and businesses without power and fanning fires that razed homes and injured five firefighters, officials said on Wednesday. Winds of up to 157 kph toppled six electricity transmission towers on Tuesday and caused one of the highest number of power outages Victoria had ever experienced.

UK imposes Serious Crime Prevention Orders on 9 Indian-origin criminals

A nine-member gang of Indian-origin criminals found guilty of smuggling goods and migrants have been placed under Serious Crime Prevention Orders (SCPOs) by the UK authorities to prevent future offending. Swander Dhal, 38, Jasbir Kapoor, 36, Diljan Malhotra, 48, Charan Singh, 46, Valjeet Singh, 35, Jasbir Dhal Singh, 33, Jaginder Kapoor, 48, Jaccar Kapoor, 51, and Amarjeet Alabadis, 32, are now under the National Crime Agency (NCA) imposed orders designed to limit their ability to engage in serious and organised crime. As members of an organised crime group, they were recently convicted for removing GBP 15.5 million from the UK to Dubai hidden in suitcases, as well as attempting to smuggle 17 migrants into the country, receiving lengthy prison sentences for the crimes.

The terms of their SCPOs, to come into effect once the offenders have served their jail sentences, include restrictions on finances, assets, bank accounts and the purchase of international travel tickets. Their orders were published this week as part of NCA's list of "active" Ancillary Orders, used to support the lifetime management of serious criminals.

"Ancillary orders are vital, allowing us to prevent future offending through a wide variety of means," said Alison Abbott, Head of the NCA's Prison and Lifetime Management Unit.

Rafah invasion could cause slaughter, UN warns Israel

The United Nations on Tuesday warned against an Israeli ground invasion of Rafah in the Gaza Strip, saying an offensive could "lead to a slaughter" in the southern region of the Palestinian enclave where more than 1 million people are sheltering.

Israel says it wants to flush out Hamas militants from hideouts in Rafah and free Israeli hostages being held there, and is making plans to evacuate trapped Palestinian civilians. "Military operations in Rafah could lead to a slaughter in Gaza. They could also leave an already fragile humanitarian operation at death's door," said U.N. aid chief Martin Griffiths. "We lack the safety guarantees, the aid supplies and the staff capacity to keep this operation afloat."

"The international community has been warning against the dangerous consequences of any ground invasion in Rafah. The Government of Israel cannot continue to ignore these calls," he said in a statement. Talks in

volving the U.S., Egypt, Israel and Qatar on a Gaza truce ended without a breakthrough on Tuesday as calls grew for Israel to hold back on its planned Rafah assault.

Truce talks inconclusive Meanwhile, talks involving the U.S., Egypt, Israel and Qatar on a Gaza truce ended without a breakthrough on Tuesday.

The city of Rafah, whose pre-war population was about 300,000, teems with homeless people living in tent camps and makeshift shelters who fled there from Israeli bombardments in areas of Gaza farther north during more than four months of war.

Israel says it wants to flush out Hamas militants from hideouts in Rafah and free Israeli hostages held captive there.

Will capture Hamas leader Sinwar dead or alive: IDF

The Israel Defense Forces (IDF) have said that their intelligence agencies were closing in on the Hamas terror leader, Yahya Sinwar and would catch him dead or alive. This was announced by the IDF spokesperson, Rear Admiral Daniel Hagari in a press statement on Tuesday night. The IDF spokesperson said that the Military intelligence and other Israeli intelligence agencies were getting valuable inputs about the exact location of the Hamas leader, widely believed to be the mastermind of the October 7 attacks.

Meanwhile, the IDF has also said that it had obtained certain visuals of Sinwar along with one of his wives and children living in a network of tunnels. However, the said footage that it got was obtained during a recent raid conducted by the Israeli troops in a tunnel network under a cemetery in the Bani Suheila area, Khan Younis which is the birthplace of Sinwar. The IDF spokesperson also said that the Israeli troops have captured close relatives of many senior Hamas leaders.

Shehbaz Sharif is likely to be next Pakistan PM

Shehbaz Sharif, the younger brother of former premier Nawaz Sharif, is expected to become Pakistan's new PM as the coalition of leading political parties led by them is set to comfortably cross the simple majority mark to form the next government after elections produced a split mandate. In a surprise move, Pakistan Muslim League-Nawaz on Tuesday night nominated Shehbaz as the prime ministerial candidate instead of the party supremo and three-time for-

mer premier Nawaz Sharif.

Earlier, Shehbaz along with Asif Ali Zardari of Pakistan Peoples Party, Khalid Maqbool Siddiqui of Mutahida Quami Movement Pakistan (MQM-P) met at the residence of Shujaat Hussain of Pakistan Muslim League-Quaid (PML-Q) for a consultative meeting and agreed on government formation. "Today we have united to tell the nation that we all accept the split mandate. I am thankful to Zardari and Bilawal (Bhutto) that they decided for their party to vote for the PML-N,"



he said.

PML-N Information Secretary Marriyum Aurangzeb has said that party supremo Nawaz Sharif has nominated the party president and his younger brother Shehbaz Sharif, 72, for the post of the country's prime minister. She added that PML-N Senior Vice President Maryam Nawaz was nominated for the post of Punjab's chief minister. "Nawaz Sharif has thanked the political parties which provided support to the PML-N (in forming the upcoming government) and expressed hope that through such decisions Pakistan will come out of crises," she said.

Indonesia: Man linked to rights abuses claims victory in prez poll

AP / JAKARTA

Defence Minister Prabowo Subianto, an ex-general linked to past human rights atrocities, claimed victory in Indonesia's presidential election on Wednesday based on unofficial tallies.

The 72-year-old candidate, who was once banned by the United States from entering for two decades due to his hu-

man rights record, told thousands of supporters in a sports stadium in the capital, Jakarta, that the victory, according to an early unofficial "quick count," was "the victory of all Indonesians."

There was no declaration by electoral officials and the two former provincial governors who also contested the election in the world's third-

largest democracy have not conceded defeat. Subianto was an army general during the brutal period of the Suharto dictatorship that ended just over 25 years ago.
